Low Income Cat Sterilization Program 2017

The Low Income Sterilization Program offers low cost spay/neuter of cats for qualifying residents of the City of Prince Albert. This procedure is done at participating veterinary clinics. The program is offered through revenue generated from the sale of cat licenses, Prince Albert Animal Care Centre and participating Veterinary Clinics. The goal of the Program is to increase the number of sterilized pets and reduce the number of unwanted and homeless cat in the City of Prince Albert.

Why Spay and Neuter?

There is a serious Pet overpopulation crisis. Over 450 cats are euthanized in the City of Prince Albert each year because there are not enough homes. The number of healthy dogs and cats euthanized each year can be greatly reduced if more pet owners spay/neuter their animals. Other benefits of spay/neutering include:

- Improved health/longer life
- No unwanted litters
- Less aggressiveness, roaming and spraying

To be eligible for the program, the participant must:

- Be 18 years of age or older;
- A resident of the City of Prince Albert;
- Be the owner and keeper of the pet being sterilized;
- Provide proof of income;

Qualifying Low Income Amounts:

- Single without children - \$18,292
- Single with children - \$28,209
- Family without children - \$28,209
- Family with children - \$28,209

Complete, sign and date the application, and return by email, fax, or regular mail. Be sure to include a copy of your proof of residency (ie Driver's License) and proof of income.
